A BILL

BILL SUMMARY

To initiate and fund the position of Student Administrator to the Board of Regents.

BE IT ENACTED by the Executive Council of the University of Colorado Student Union, THAT:

- SECTION 1:** UCSU shall allocate \$3,300 from Central Reserve to initiate and fund the Student Administrator to the Board of Regents, operating under the following job description:
1. The position would rotate to each of the four campuses. The hosting campus would submit the name(s) of one to two students to the Secretary of the Board of Regents and Intercampus Student Forum. Upon the approval of the Secretary and three of the four campus student body executives, the new student administrator would begin his/her term on July 1 and end it on June 30 at the end of the fiscal year. The position would require 20 hours of work each week, most to be spent at the Board of Regents office in Regent Hall at Boulder and would be paid.
- SECTION 2:** Objectives of the position shall include:
1. To provide a stronger communication link between the Board and the four student governments.
 2. To provide in-depth analysis to the Board on issues affecting students on a university-wide and individual campus basis.
 3. To aid Intercampus Student Forum in being better informed of the issues placed before the Board.
- SECTION 3:** General responsibilities of the student Administrator would include:
1. Active participation on Intercampus Student Forum and other committees as deemed appropriate by the Intercampus Student Forum.
 2. Participation in activities of the Board of Regents office as deemed appropriate by the Secretary of the Board.
 3. Coverage of the monthly Board of Regents meetings as well as the Regent subcommittee meetings on the four campus.
 4. Meetings with the following:
 - a. The Regents
 - b. Secretary of the Board of Regents
 - c. President of the University
 - d. Assistant Secretary of the Board of Regents

- e. Student Body Executives on each campus
 - f. Student governments from each campus
 - g. Other personnel as deemed necessary by the Intercampus Student Forum
- 5. The student administrator's assignment within the Office of the Board of Regents will be under the direction of the Secretary of the Board or person specified by him.
 - 6. Communication of the Board of Regents' position on issues to each student population on every campus, and mediation of student problems, questions, and/or issues directed toward the Board of Regents.

SECTION 4: The position shall provide the following benefits to the Board of Regents:

- 1. Additional student input on policies that directly and indirectly affect students.
- 2. Research by students on student problems. (The Board would not need to seek out student input.)
- 3. Communication to students on all campuses of the Board of Regents' position on issues.


SECTION 5: The position shall provide the following benefits to the student administrator:

- 1. Opportunity to help students throughout the university system.
- 2. Exposure to the Board of Regents and high level CU administrators.
- 3. Experience in mediation and enhancement of oral and written communication skills as well as problem-solving ability.

SECTION 6: This bill shall take effect upon passage.
