### **BILL HISTORY**

Due to Regental pressure concerning the Cultural Events Board, the UCSU Tri-Executives, CEB, SBA and administration have met to air all concerns and hammer out a compromise/response. After examining many alternative plans, the creation of a new Executive Council standing committee (with charge listed below) is viewed as the best compromise. An office of Parliamentarian will also be created. Voting positions will not be renewable, to avoid any one person's domination of the Board.

### BILL SUMMARY

This Bill will create a new standing committee entitled "CEB Review Committee." This Bill will also create an office of Parliamentarian.

BE IT ENACTED by the Executive Council of the University of Colorado Student Union, THAT:

SECTION 1:

Composition:

5 member committee

- 1) 2 members elected by the body
- 2) The President Pro-Tempore
- 3) 2 members appointed by the Executives

The members of the CEB Review Committee shall sit for a one year, non-renewable term.

**SECTION 2:** 

Committee Charge:

- 1) The Executive Council shall hold 30% of the CEB budget in reserve for the fiscal year. This amount is to be released at Council's discretion upon the recommendation of the Review Committee.
  - A) The reserve holding provision will be renewed after a two year period to determine whether it is necessary. If the CEB has performed well, the provision will be discontinued.
- 2) The Review Committee shall conduct a review of that semester's programs. The Committee shall be familiar with concerns of students, student groups, and the CEB.

The report shall address CEB's performance in programming, finances, and in achieving a program representative of diverse popular opinion and sufficient political balance.

3) The Committee will also conduct an informal report on the upcoming semester to assure that any inequities in the past program will be compensated in the following semester.

1. This was later changed to 40% by the Board of Regents.

# 25 EXECUTIVE BILL #1

A) If the Committee finds the CEB program unsatisfactory, the Committee is directed to withhold the CEB budget until sufficient revisions are made in the forthcoming CEB program.

SECTION 3: Due dates of the report from the Review Committee shall be

November 1 and April 1.

SECTION 4: Voting positions on the CEB:

Voting positions will consist of a two year non-renewable term, with

a third term if elected officer (chair, or speaker).

SECTION 5: Parliamentarian:

A separate office of Parliamentarian will be created from the voting

members. The function of the office will be to assure that CEB

follows all the UCSU's Constitution, By-Laws, and CEB's By-Laws and

Funding Guidelines.

SECTION 6: This Bill takes effect upon passage.
