BILL HISTORY

UCSU is proud to be hosting the national conference for the United States Student Association this August. We will welcome schools such as Harvard, University of Iowa, University of Washington, U.C.L.A., Notre Dame and many community colleges. U.S.S.A., the national student voice, represents approximately 425 schools of nearly 3½ million students.

Because of UCSU's size and influence, it is considered a model government for smaller, less powerful schools; this was a major factor in U.S.S.A.'s selection of CU, Boulder for its 1986 national conference.

Established in 1947, the United States Student Association is the oldest and largest national student organization working to ensure accessible, quality education for all. U.S.S.A. is unique because it is for students, run by students, and is open to all post secondary schools.

U.S.S.A. has led the student lobbying campaign against the massive cuts in vital student aid programs. This year's theme is "Education at a Cross Road" with workshops focusing on civil rights, electoral action, financial aid, education reform and incentives for student leaders. By virtue of being the hosting institution we have a direct voice onto the national level and have a great deal of influence on what students will take back to their respective student bodies.

At this national conference U.S.S.A. will be determining its agenda for the next year. All procedures are democratic and the organization adopts any plans passed by the members at the conference. Any and all ideas are welcome and can be submitted for discussion at the plenary sessions.

Ensuring a bright future for higher education is what U.S.S.A. is all about; UCSU is proud to be a vital part of this year's plans. We have worked hard to get good deals on a lot of our costs, and UCSU will be reimbursed for many of its expenses as specified on the breakdown sheet.

BILL SUMMARY


Allocates an amount not to exceed \$10,289.49 from Central Reserve to fund advertising, catering and events to take place throughout the 1986 national conference of U.S.S.A. at the University of Colorado, Boulder. Council will be reimbursed \$5,788.25.

Therefore, BE IT ENACTED by the Executive Council of the University of Colorado Student Union THAT:


- SECTION 1: An amount not to exceed \$10,289.49 shall be allocated from Central Reserve to fund the following areas of the 1986 U.S.S.A. Conference: (See attached budget sheets.)
- SECTION 2: The U.S.S.A. Coordinator shall continue to search for outside/alternative financing.
- SECTION 3: The U.S.S.A. Coordinator shall report to the Finance Board on the financial status of the conference.
- SECTION 4: The U.S.S.A. Coordinator shall write a summary report on the financial status and success of the conference.
- SECTION 5: This bill will take effect upon passage.




