A BILL

BILL HISTORY

Since 1984 the University of Colorado Student Union has been a fee paying member of the United States Student Association and has been in full receipt of the benefits offered by the nationally recognized student organization. In the summer of 1986 UCSU hosted the USSA Summer Congress for the second time. Since UCSU's joining of USSA and due to our active participation in the past four summer congresses the Student Union has grown immensely in its organizational abilities. The success of the 1986-87 Tuition Freeze campaign was due in large part to the hard work of UCSU and the knowledge gathered from various USSA workshops and conferences. Also, the creation of the Colorado Student Association can be attributed to USSA contributory efforts and the successes of other statewide student associations affiliated with USSA.

UCSU's continued participation in USSA will only serve to strengthen our Student Union. This year the USSA summer congress will be held in Madison, Wisconsin between August 7 and 12. It would be appropriate to send eight UCSU representatives. (This is the total number of votes we have in the general assemblies). However, in order to conserve UCUS funds we plan to send six UCSU representatives to The Congress. These UCSU representatives will be as follows: Executive Staff members Angela Martinez and Jessica Fowler, Tri-Executives Eddie Pacheco and Elizabeth Burpee, one voted upon Executive Council Representative and one student-at-large to be chosen by notices to student groups and interviews. These people have been carefully selected due to their qualifications, current job projects and expressed interest. We hope that the delegation, as it stands, will be representative of the Student Union's interests. The above named delegation is in accord with USSA's affirmative action guidelines.

BILL SUMMARY

This Bill shall allocate an amount not to exceed \$2057.48 (\$1967.00 + \$90.48 GAR) to send six UCSU representatives to the 1987 summer congress in Madison, Wisconsin for the purpose of strengthening UCSU ability to serve the students at the University of Colorado in Boulder.

BE IT ENACTED by the Executive Council of the University of Colorado Student Union, THAT:

SECTION 1: \$2057.48 shall be taken from the Central Reserve Account for the 1987 USSA summer congress.

SECTION 2: The money shall be broken down and spent as follows:

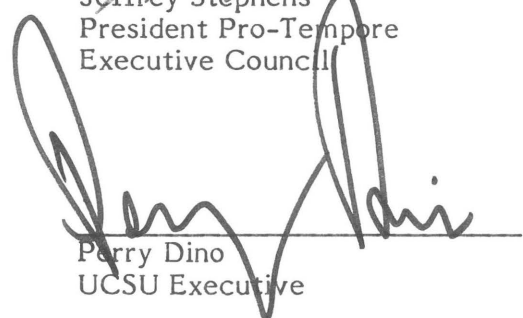

A BILL

BILL HISTORY

With the formation of the Colorado Student Association in the winter of 1987 the University of Colorado Student Union voiced moral and financial support for the success of CSA. Thus far, CSA has been successful in educating many students in Colorado on issues such as state and national funding for higher education and on the importance of student leadership. CSA is currently recruiting new member campuses and plans to send two CSA representatives to the Statewide Student Association conference organized by the United States Student Association in Sausalito, CA. The dates of the conference are July 17-19, 1987. In order to maintain CSA's momentum and in order to help solve many pressing and hindering problems which CSA now faces, UCSU will send one representative to the SSA conference. As UCSU was one of the key founding organizations of CSA it is vital that UCSU's presence and activism remain with CSA until the organization is stronger. Potentially, CSA could be a very strong voice at the statewide level, in the Governor's office and at the local administrative level for the furthering of Colorado student goals. It is appropriate that Vicky Powell (Student Administrator to Financial Aid) attend this conference in order to represent UCSU. She is both currently active in CSA's functioning and plans to expand her involvement with the organization.

BILL SUMMARY

This Bill shall allocate an amount not to exceed \$470 from the Central Reserve account to reimburse the UCSU Operations account in order to fund one UCSU representative at the SSA conference in Sausalito, CA between July 17 and 19, 1987.

BE IT ENACTED by the Executive Council of the University of Colorado Student Union, THAT:

- SECTION 1: An amount not to exceed \$470 + GAR shall be allocated from the Central Reserve Account in order to fund one UCSU representative at the SSA conference in Sausalito.
- SECTION 2: \$100 shall be spent on registration fees.
- SECTION 3: \$185 shall be spent on gas reimbursement.
- SECTION 4: \$185 will be spent on one-way airfare to San Francisco.
- SECTION 5: This Bill takes effect upon passage.

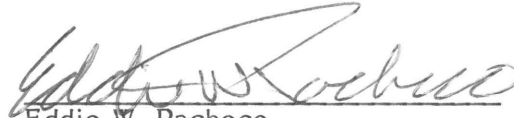

A BILL

BILL HISTORY

The Gaudino Project is a national educational endeavor that deals with student leadership, peace studies and non-violent alternatives to political action. Dominic Kulik, Jackie Lanzarone, and David Yaskulka were students at Williams College who initiated a series of peace studies on their campus and are now running the Gaudino Project. They were extensively involved in student leadership on their campus and are committed to taking their ideas on peace studies all over the United States. They will be conducting workshops on such subjects as "the history, theory and practice of non-violence," "the initiation and continuance of Peace Studies courses at CU," and "developing effective leadership techniques." The workshops will be part of a continuing UCSU effort to strengthen the Peace and Conflict Studies program at the University of Colorado in Boulder. The workshops are currently scheduled to take place on June 30 and July 1 in the UMC. Several faculty members are involved in this project and plan to take care of the housing costs for the workshop coordinators.

BILL SUMMARY

This Bill shall allocate an amount not to exceed \$533.25 (\$509.80 + \$23.45 GAR) from the Central Reserve account to cover the honorarium costs and advertising costs for the Gaudino Project workshops to be held on June 30 and July 1, 1987.

BE IT ENACTED by the Executive Council of the University of Colorado Student Union, THAT:

- SECTION 1: An amount not to exceed \$533.25 shall be taken from the Central Reserve account for the Gaudino Project.
- SECTION 2: \$250 shall serve as honorarium for Dominic Kulik, Jackie Lanzarone, and David Yaskulka.
- SECTION 3: \$184.80 shall be used for two 1/4 page ads in the Colorado Daily at \$92.40 per ad. (Since the workshops will be held on Tuesday and Wednesday, advertising in the Campus Press the week before would probably not be a wise use of the advertising dollars.)

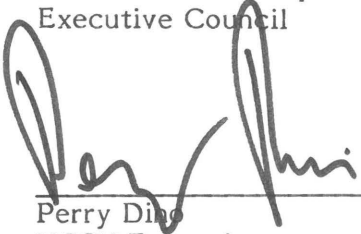

A BILL

BILL HISTORY

The issue of daycare has been a priority since 1971 for UCSU. Many attempts have been made to establish daycare on campus. Unfortunately, due to the limited space available on the University of Colorado, Boulder campus, this has been a hard project to complete. Research has been done in the last few months to ascertain what options surrounding daycare are available to UCSU. A steering committee has been formed to discuss these options and to explore new ones.

One option is to assist the present daycare facility at Family Housing with their immediate needs. The director of Family Housing has outlined these needs to the daycare steering committee. These needs are under consideration. A second option is to take preparatory steps in forming a new daycare center on campus. Before any action is taken, the steering committee has come to the decision that a needs analysis must be done. This analysis will help the steering committee decide what the exact needs of the University community are and whether or not the options presently available meet the needs. A mail-in survey will ask the specific questions needed.

BILL SUMMARY

This Bill allocates \$844.00 + GAR (4.61%) to fund a mail-in survey designed to specify immediate needs and concerns of the present student-parent community at the University of Colorado at Boulder.

BE IT ENACTED by the Executive Council of the University of Colorado Student Union, THAT:

- SECTION 1: An amount not to exceed \$844.00 + GAR (4.61%) be allocated from Central Reserve to fund a daycare mail-in survey.
- SECTION 2: A written report is to be submitted to Executive Council concerning the results from the mail-in survey, pursuant to the provisions of 24 ECB #4.
- SECTION 3: This Bill takes effect upon passage.

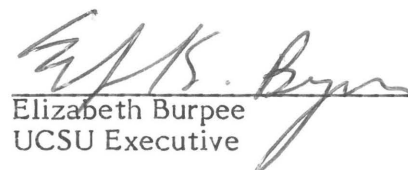

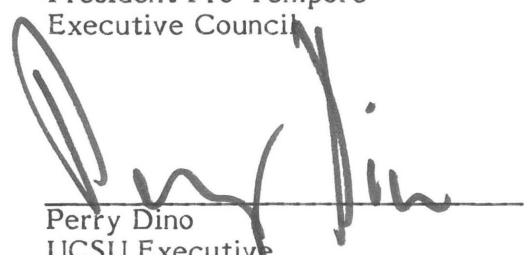

BILL HISTORY

Financial Aid is a concern of over 50% of students on campus, yet it remains a process in which students feel they have little control. UCSU has the opportunity to send a student, SA to Financial Aid Vicky Powell, to a conference sponsored by the National Association of Student Financial Aid Administrators. Financial Aid Director Jerry Sullivan and his two associate directors will also be attending. The conference will be held in Washington D.C., July 22-25 and will address specific issues for financial aid staffs (see agenda). During the conference there will be an opportunity for attendees to speak with the members of the Colorado Delegation about funding for higher education, specifically financial aid. This conference provides a unique venue for financial aid education which will directly benefit a majority of the student population.

BILL SUMMARY

This bill allocates \$450.06 for Vicky Powell to go to the NASFAA Conference in Washington D.C. July 22-25, 1987.

BE IT ENACTED by the Executive Council of the University of Colorado Student Union, THAT:

SECTION 1: An amount not to exceed \$450.06 from Central Reserve to fund Vicky Powell attending the NASFAA Conference July 22-25, 1987 in the budget provided.

SECTION 2: Any money not used for the conference will be rebated to Central Reserve.

SECTION 3: A report on this conference will be presented to council by August 20, 1987.

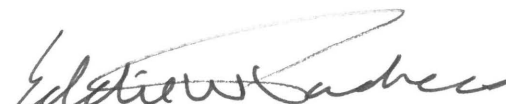

A Bill

On June 18, 1987 the Executive Council of the UCSU passed, by special order, with a vote of 10 in favor, 3 against and 0 abstentions, a bill sending 6 members of the UCSU to the USSA Annual Congress in Madison, WI. In the bill was included money for gas milage from Boulder to Madison. Due to the lack of funds in the Central Reserve account for FY 86-87 the gas money from Madison back to Boulder was not included. This bill would allocate a small amount in order to fund the congress participants return trip gas expenses. Included in the bill of 18 June 1987 were sufficient funds for only 4 days worth of food. Since the conference participants will be expending their own money for the other four days of the congress this return trip gas money would greatly benefit all participants.

BILL SUMMARY

This bill shall allocate an amount not to exceed \$139.80 to be used for the return trip gas expenses from Madison, WI to Boulder, CO for the USSA Annual Congress participants.

THEREFORE BE IT ENACTED by the University of Colorado Student Union THAT:

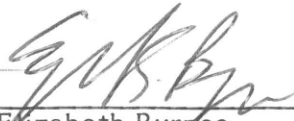

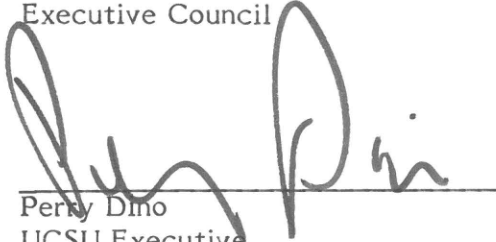

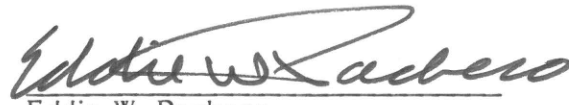

BILL HISTORY

This year on August 24 & 25 the University Learning Center is sponsoring the first annual Information Fair. It will be held in the Glenn Miller Ballroom from 9:00am to 5:00pm. The Fair is open to all students and is designed to provide personal and academic support services. Various groups will have booths set up to supply information (i.e. Tutorial Services, Career Services, UCSU, GSAC, Academic Skills). Sixteen to twenty booths are expected.

BILL SUMMARY

This bill asks for \$485.10 plus G.A.R. to cover costs of advertising and signs for the Information Fair.

BE IT ENACTED by the Executive Council of the University of Colorado Student Union, THAT:

SECTION 1: An amount not to exceed \$485.10 plus G.A.R. will be allocated from Central Reserve to pay for advertising and signs for the Information Fair.

SECTION 2: All student groups who receive special event funding shall submit a written report to be turned in to the Pro-Tempore and kept on file for access.

The Report shall include the following: 1) General overview of the events and the phases of that event, 2) attendance of all phases of the event, 3) did the group sponsoring the event feel they accomplished their goals set forth prior to the event, 4) a detailed account of expenditures.

This report shall be submitted within 30 days of the end of the event. Failure to do so may jeopardize future funding from UCSU Executive Council.

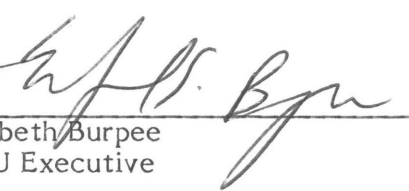

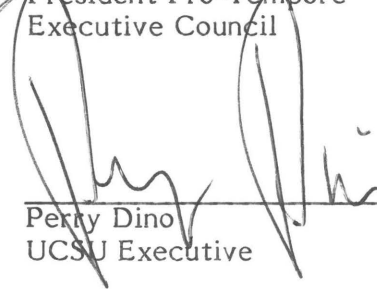

SECTION 1: An amount not to exceed \$455.20 + GAR shall be allocated from Central Reserve to fund advertising for voter registration.

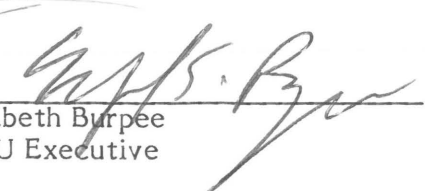

This bill shall allocate an amount not to exceed \$2201.26 from Central Reserve towards promotion of National Alcohol Awareness Week, October 19 - 23rd.

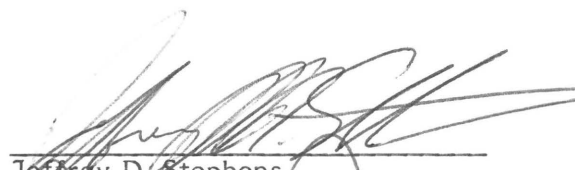

BILL HISTORY

The United States Student Association is holding the first of three Board meetings for the Academic Year 1987-88. These Board meetings are a crucial element in membership of the USSA. During Board meetings policies, endorsements, and decisions concerning the direction of USSA, are debated and decided upon.

This year the Rocky Mountain region elected two Board members: Valarie Eilert and Guerin Geen from UCSU. Tri-Executive Elizabeth Burpee was also elected to the board from the Womens Caucus. Although three people from CU will be attending the board meeting in Washington D.C., only one person's airfare and expenses are being asked for from Executive Council. The other monies will come from individual pockets.

This year a major project for the UCSU will be the further development of a formation and statewide student association for Colorado. USSA has been instrumental in the formation and strengthening state associations and we feel that their continued input will bolster CSA. USSA has also been involved with the formation of the National Higher Education Awareness Week, a large amount of legislative lobbying for higher education, exploring the university's role in society, and has authored a provision that was added to the Higher Education Reauthorization Act. This provision called for Pell grants for half-time students who have been increasingly pushed into the job market due to lack of financial aid. The USSA continues to work towards making higher education a right for all students and UCSU should take advantage of this rare opportunity to have three CU board representatives present to help plan for the future of this nation's students.

BILL SUMMARY

BILL HISTORY

For the past 2½ years, Community in Action has conducted educational campaigns around the issue of CIA activities. An integral part of these campaigns has been to bring highly placed, former CIA officials to speak on campus. This has also served as a counterpoint to the CIA official who is allowed to address a plenary session at the World Affairs Conference. On November 9th, we have the opportunity to bring Philip Agee to the campus. Mr. Agee is a 12 year veteran of the CIA. His principal stations were in Ecuador, Uruguay, Mexico and Washington. He was the first major figure to publicly expose CIA wrongdoings abroad. His position is one of belief in the need for an effective intelligence service "to prevent war. But that's a far cry from using info to undermine an elected government."

This year is the first time in 16 years that he has been allowed to travel in the U.S. Mr. Agee's work, both in the CIA and out, has made him a formidable expert on the political systems he has operated within as well as CIA covert operation methodology. Hearing Mr. Agee speak is an unprecedented opportunity to get an intimate glimpse of the inner working of the CIA.

He continues to publish books on the need for a responsible intelligence service and is a key figure in the debate over U.S. covert policies abroad. His appearance is especially timely and appropriate in view of the recent Iran-Contra hearings. His knowledge and experience provide a rare educational opportunity.

BILL SUMMARY

This bill shall allocate an amount not to exceed \$1,900 from Central Reserve in order to fund the honorarium and advertising expenses for Philip Agee's appearance on the Boulder campus November 9, 1987.

BE IT ENACTED by the Executive Council of the University of Colorado Student Union THAT:

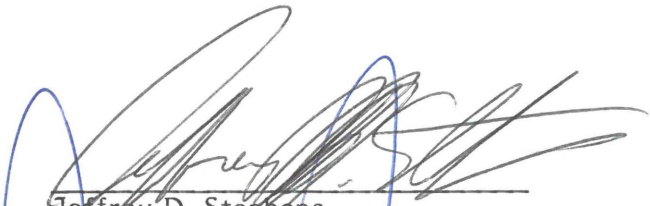
