BILL HISTORY

The initial \$5,000 transfer of student fees from Executive Council to Local Schools Council was enacted to support small groups and to keep these small groups from backlogging Executive Council Agendas, but instead of expressly funding small groups seeking monetary aid, the \$5,000 has been used to double-fund large groups.

The transfer was not composed of directly allocated student fees, but of student fees allocated to the Executive Council, so in double funding student groups by referring them to both of the respective councils, we as a student union of representatives are advocating and participating in a redundancy that only serves to confuse and mislead the students we represent.

Preventing double funding would reflect the sound judgement and mature responsibility in spending of student fee monies, as advocated by the Student Fee Guidelines.

BILL SUMMARY

This Bill prevents the double funding of any item presented before both of the Executive and Local Schools Councils until such time that Local Schools Council receives direct allocations of mandatory student fees from the students.

BE IT ENACTED by the Executive Council of the University of Colorado Student Union, THAT:

SECTION 1: Student Groups or Local Service Organizations requesting funds from Executive Council shall not be referred to Local Schools Council in the event that total funding is not obtained. Funding for an event shall not be funded by the Executive Council if they also receive or will receive funding from the Local Schools Council for the same event.

SECTION 2: If a student group or local services organization, notwithstanding these provisions, receives additional funding from Local Schools Council, it will be the responsibility of the Finance Director to stop disbursement of all funds allocated by the Executive Council.

SECTION 3: This Bill takes effect upon passage and remains in effect until Local Schools Council receives student fee monies directly from the student body or until Local Schools Council adopts a provision such as this into their bylaws, whichever comes first.

BILL HISTORY

Local schools council has proven itself to be an effective funding mechanism in the past. Questions have been raised in the past as to where the money for local schools should come from. This bill would solve the funding question and guarnatee the local schools council \$10,000 per year to fund to small student groups who otherwise wouldn't get funded. Of course, as a referendum, the final say will be up to the students.

BILL SUMMARY

A student referendum asking the students to allow 25¢ of their student fees to be used to fund Local Schools Council.

BE IT ENACTED by the Executive Council of the University of Colorado Student Union THAT:

SECTION 1: The following shall be inserted on the Fall 1987 Ballot as a referendum: "Would you be willing to add 25¢ to your student fees to be used to fund Local Schools Council. The funds will be allocated to student groups pursuant to Local School by-laws."

SECTION 2: This student referendum will last for 2 years, and will be renewed on the Fall 1989 Ballot.

BILL HISTORY

CU-Boulder is mandated to have a published guide of employer and employee rights and responsibilities. To fulfill this requirement the Office of Financial Aid has traditionally coordinated the publication of the Student Employment Handbook which has not been updated in over 4 years. In those 4 years, UCSU has been involved in the revision of the handbook through the Student Employment Advisory Committee, with the understanding and approval that UCSU and the Office of Financial Aid would jointly fund the publication of the handbook. UCSU is committed to promoting a good working relationship between student employees and their university employers and to that end it would be advantagous to publish the Student Employment Handbook as soon as possible.

BILL SUMMARY

This bill allocates \$850.00 + GAR to be paid to the Office of Financial Aid for the publication of the Student Employment Handbook.

BE IT ENACTED by the Executive Council of the University Colorado Student Union THAT:

SECTION 1:	An amount not to exceed \$889.19 from Central Reserve will
	be transferred to the Office of Financial Aid to fund the

	UCSU is funding half of the publication costs and any money
	unused will be returned to Central Reserve.

SECTION 2: All student groups who receive special event funding shall submit a written report to be turned in to the Pro-Tempore and kept on file for access.

The Report shall include the following: 1) General overview of the events and the phases of that event, 2) attendance of all phases of the event, 3) did the group sponsoring the event feel they accomplished their goals set forth prior to the event, 4) a detailed account of expenditures.

This report shall be submitted within 30 days of the end of the event. Failure to do so may jeopardize future funding from UCSU Executive Council.

SECTION 3:

This council wishes to express its concern in the funding of this issue and in the future hope the administration will recognize its responsibility in this matter.

BILL HISTORY

In the UCSU Constitution Article IX * Section A * Part 4 it states "Grounds for impeachment shall be failure to substantially fulfill the duties of his/her office, including absence from four consecutive meetings without substantial excuse." This clause effectively allows Executive Council members to attend only 25% of all Executive Council meetings without any kind of worry about the consequences of his/her actions. The only way to amend the UCSU Constitution is to put forth a referendum question to the students. By tightening up this rule we will have a better informed, more consistent Executive Council.

BILL SUMMARY

The following referendum question will be placed on the Fall 1987 ballot: "Presently the UCSU Constitution allows a member of Executive Council to miss four consecutive meetings. In order to provide a consistent and responsible Executive Council should Article IX 'Section A 'Part 4 of the UCSU Constitution be amended to read 'Grounds for impeachment shall be failure to substantially fulfill the duties of his/her office, including absence from three meetings in a legislative session without a valid and reasonable excuse?"

BE IT ENACTED by the Executive Council of the University of Colorado Student Union THAT:

SECTION 1: The election commissioner shall place on the Fall 1987 ballot the following question: "Presently the UCSU Constitution allows a member of Executive Council to miss four consecutive meetings. In order to provide a better record of attendance should Article IX * Section A * Part 4 of the UCSU Constitution be amended to read 'Grounds for impeachment shall be failure to substantially fulfill the duties of his/her office, including absence from three meetings in a legislative session without a valid and reasonable excuse?"

SECTION 2: This referendum is binding.

Since 1968, the University of Colorado Student Union has sought to make the University Book Center more responsive to student interests. That year, the Board of Regents established 4 criteria that if reached would allow the students to form an independent Bookstore Cooperative. While the students failed to meet the criteria in 1968, the goal of student empowerment continued.

The UCSU Book Center Task Force, appointed by the Tri-Executives, has been working with Administration since December to 1.) identify the problems of lack of student imput and inefficiency in Book Center operations and 2.) establish that these problems cannot be resolved within the existing structure of the bookstore. At this stage, it is crucial that students prove their support for an alternative Bookstore structure and to this end, we submit this referendum for the Fall 1987 ballot.

A student referendum asking the students to declare their support of a student owned and operated bookstore cooperative, independent of the University.

In an effort to insure adequate funding for out-of-state travel by student groups within the two-ticket maximum, the Executive Council has expressed a desire to increase the current \$500 maximum. This by-law amendment raises that maximum to \$750, an amount sufficient to pay for round-trip air tickets (2) to just about anywhere in the lower 48 states. All other provisions in the bylaws governing out-of-state travel would remain unaffected by this change.
