Representatives will be present from such corporations as General Motors, Keebler, United Air Lines, and Proctor and Gamble. There will be Budgeting, Human Resorce Management, Forecasting & Inventory Management, and Electronic Data Interchange Applications. Last year four members of the Delta Nu Alpha Transportation Fraternity had the opportunity to attend this conference. Two of those members, Joe McCreary and Michelle LeBlance made contacts with company representatives and enabled U of C to attract a greater number of recruiters. Company, ABF Freight Lines, and Hewlett-Packard Company were so impressed with the four attending members that they came to the University of Colorado campus to interview not only transportation majors, but also marketing, finance, communication, english and economic majors.
