**BILL HISTORY**

Further, the 5th floor lounge will celebrate the outstanding contributions of minority students to the University community.

**BILL SUMMARY**

This bill will direct the UMC Board to name the 5th floor lounge in honor of Sal Aunese. Further, the UMC Board will work to incorporate in the 5th floor lounge appropriate material honoring the outstanding contributions of minority students to the University community.

**BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:**

SECTION 1:           The UMC Board shall name the 5th floor lounge in honor of Sal Aunese.

SECTION 2:           The UMC Board shall purchase a plaque denoting the new




