A BILL

BILL HISTORY

UCSU joined USSA in August through our membership in CSA. USSA hosts two events each year for the benefit of their membership, National Congress, and Legislative Conference. The congress is the time when USSA sits its agenda for the coming year, electing national officers, amending the constitution, and passing a policy platform.

The Legislative Conference, organized by the executive officers and the national board of directors is a legislative training session for students.

The Legislative Congress is held in Washington D.C. each spring and focuses on the legislative functions of USSA.

This years congress will be held March 2-5. The 2-4 will be filled with workshops, discussion groups, and addresses by congressional leaders. The 5th is set aside as a time for students to practice the skills they have learned by visiting their states' congressional delegation, to talk with them about education issues of the upcoming session.

BILL SUMMARY

This bill allocates \$2202.00 + GAR or (\$458.00 per person x 4) for 4 students to attend the USSA Legislative Conference in Washington D.C. March 2-5, 1990.

BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:

SECTION 1: An amount not to exceed \$2202.00 + GAR will be allocated from Central Reserve to fund sending 4 students to attend the USSA Legislative Conference in Washington D.C. March 2-5, 1990.

SECTION 2: The delegation from Boulder shall include at least one woman and at least 2 students of color, 2 reps. from Leg. Council, 1 Exec. or Exec. staff and 1 student chosen by a committee created for this purpose. One person from the Leg. Council, Exec., or Exec Staff must be a person of color. The student at large must be a person of color.

SECTION 3: The Delegation from Boulder shall report to Legislative Council both orally and written within two weeks.

SECTION 4: This bill takes effect upon passage.


