BILL HISTORY

As a member of USSA the University of Colorado, Boulder, has a right and duty to make USSA aware of issues we would like them to focus on. Although USSA is currently regarded as our best or only option to deal with issues important to CU at a national level, we must continue to make these interests known to them. There are no current plans to withdraw participation from USSA.

Because student educational issues are as widely coagulated for Council as they are for the student body, I do not think it is in the best interest of council to try to include/exclude certain issues on an agenda, but to include all that are important and try more importantly to prioritize the way we would like USSA to dole out its energies to deal with them.

It is in this (hopefully) united spirit that I propose the following method to deal with an agenda.

Lastly, I think it is important that we update this agenda yearly and that it be finished in time to give to the delegates attending the USSA Congress each Summer.

BILL SUMMARY

This bill outlines a procedure for UCSU to construct an agenda of prioritized educational issues.

BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:

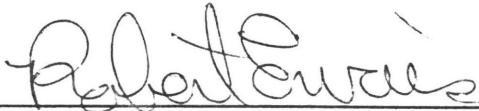
- SECTION 1: UCSU will complete an updated agenda of national educational issues in time for the USSA Rocky Mountain Region Board member to take to the USSA Conference in March of 1990, and by the end of each spring semester.
- SECTION 2: This agenda will be used as a guide in setting the priorities at the Rocky Mountain Region meeting at the USSA National Congress each Summer.

SECTION 3: An agenda will be created following a discussion in Legislative Council open hearing on issues to appear on the agenda. The Agenda will be created in the following manner. Each Representative-at-Large and CCS School and the Tri-Executives will prioritize a list of 10 educational issues. The issue with the most priority will be listed as 10 down to the least as a 1. Then all 21 of the lists will be compiled and the issues with the most "points" will be put at the top of the agenda, and the lowest at the bottom.

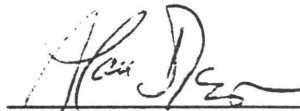
SECTION 4: This bill takes effect upon passage.

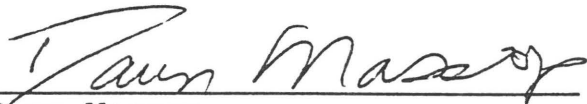

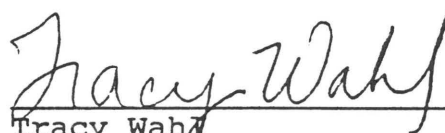
