A BILL

BILL HISTORY

Second Wind Productions was founded in 1985 to present plays centering on people of color. From the outset, Second Wind has concentrated on community outreach. Through the generosity of their donors, they have been able to present high-quality theatrical productions that otherwise would not be available in Boulder. Their shows are generally free, therefore, they are accessible to all members of the greater Boulder-Denver community. They have played an active role in promoting racial understanding here and throughout Colorado.

The Blood Knot, was first performed in South Africa in 1962. It is an early work by internationally known, South African exile playwright Alhol Fugard. This play is about two brothers, one who looks White, the other who looks Black. The paly is about their finding a reconciliation despite the separation created by their appartently different colors. It is an insightful look at social forces separating Black and White people, very often despite their wishes.

The Blood Knot will be presented at Old Main theatre, February 15-18, 22-25; 8:00pm. February is also Black History Month.

BILL SUMMARY

This bill allocates a sum not to exceed \$3,000.00 + GAR towards the production costs of Second Wind's The Blood Knot to be performed at Old Main, Feb. 15-18 and 22-25.

BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:

SECTION 1: This bill allocates \$3,000.00 + GAR from Central Reserve to Second Wind Productions to help finance their production costs for The Blood Knot.

SECTION 2: A written report will be submitted pursuant to 24 ECB #4.

SECTION 3: This bill takes effect upon passage.




