BILL HISTORY

The National American Institute of Architecture Students (AIAS) FORUM is the annual national educational symposium of architectural students. Over 1,000 students from 144 schools in the United States, Canada, and Puerto Rico will attend this year's meeting in San Francisco on November 20-25, 1990. The University of Colorado chapter of AIAS intends to send at least 8 people to the 1990 FORUM in an effort to make a strong showing. AIAS has been working on fund-raising events such as an architectural model raffle and a phone-a-thon to help pay for this trip.

The college of ENVD is in the midst of restructuring and sorely needs to get some recognition of the efforts it has made in avoiding termination of its existence. Part of this effort involves showing stronger participation/representation of its student groups at the national and regional levels. This annual symposium is the biggest event for students in AIAS. At this event there will be seminars on important professional issues, architectural trends and the future of architectural education. In order to show that we have a young, improving program with a bright future it is imperative that AIAS make this year's delegation a strong one.

BILL SUMMARY

The bill allocates \$710.00 + GAR for airline tickets for two people to attend the 1990 AIAS FORUM in San Francisco.

BE IT ENACTED by the Council of Colleges and Schools of the University of Colorado Student Union, THAT:

SECTION 1: This bill allocates \$710.00 + GAR from the Council of Colleges & Schools account to send two representatives to the 1990 AIAS FORUM.

SECTION 2: A written report will be submitted pursuant to 24ECB#4.




