A BILL

BILL HISTORY

Since 1931, the Alpha Iota Chapter of Kappa Kappa Psi, National Honorary Band Fraternity, has served the bands of the University of Colorado. Kappa Kappa Psi exists for five purposes: to promote the welfare of college bands, honor outstanding band members, develop leadership, provide worthwhile social activities for band members, and encourage strong relations between college bands when they meet.

The Alpha Iota Chapter at CU provides many services, including: hosting receptions for concert ensembles, staffing key positions in CU Band Day, providing "get acquainted" activities for Band Camp (a great service for new CU students), establishing funds to commission an original composition for band, staffing summer "phone-a thons" to gain new members for all CU bands, and helping the Department of Bands with mailings.

The Kappa Kappa Psi Midwest District Convention will take place April 4-7, 1991 at the University of Missouri at Columbia. Two district officers (out of five) are from CU, and CU is recognized as an outstanding school in the district. At the convention, members will gain new ideas for service projects, recruitment of band members and fundraising, as well as share ideas that have worked well at CU.

BILL SUMMARY

To allocate \$559 plus GAR from the Council of Colleges and Schools account to help send 12 students to the Kappa Kappa Psi Midwest District Convention in Columbia, Missouri on April 4-7, 1991.

BE IT ENACTED by the Council of Colleges and Schools of the University of Colorado Student Union, THAT:

SECTION 1: Council of Colleges and Schools allocate \$559 plus GAR to send 12 students to the Kappa Kappa Psi Midwest District Convention in Columbia, Missouri on April 4-7, 1991.

SECTION 2: A written report will be submitted pursuant to 24 ECB#4.

SECTION 3: This bill takes effect upon passage.
