BILL HISTORY

Because of the inherently transient nature of student leadership, USSA found that students were continually reinventing the wheel in their organizing efforts, putting little effort into the strategy of issue campaigns.

The GrassRoots Organizing Weekends (GROW) training sessions were started in 1985 by the National Student Education Fund (NSEF), USSA and the Midwest Academy. The training sessions are based on the idea that there are certain techniques that lie behind all successful organizing campaigns, and these skills can be learned. The skills are not issue-specific; students can apply them to campaigns of most concern to their own campuses.

The two and a half day program is designed for active student participation, mixing lectures, audio-visual presentations, exercises and role-plays. Participants are recruited from diverse constituencies within the student population, and special emphasis is placed on the importance of building bridges between groups.

Training sessions generally cost NSEF about \$3,000.00. Members of USSA can get GROW training sessions at their campuses for a much reduced rate. In order to keep costs down and to encourage commitment to attend the entire workshop, CU-Boulder students will be charged \$10.00 for the entire weekend. Non CU-Boulder students will be charged \$25.00.

BILL SUMMARY
