BILL HISTORY

This proposal is a request for funds concerning the annual convention for the National Association of Accountants. The convention, which will be held in Chicago, Illinois this year, is of great interest to our club. We have been unable to send a representative from our club to the annual convention the past couple of years due to a lack of funds. This year our club's membership has greatly increased and we feel that this convention is essential to our continued success. The knowledge and experience gained by attending the conference will help us retain current members and attract new members in the future.

The goal of AAS is to expose students to many different career paths in the accounting field. There are no requirements to become a member, thus we enjoy a wide representation off students from freshman to the graduate level.

This year we would like to send two AAS representatives to the convention scheduled for June 23-26. The representatives will attend sessions with topics ranging from Financial Planning to Competing in a World Economy, to Effective Communication. - SECTION 3: This bill takes effect upon passage.


