BILL HISTORY

The International Association of Students in Economic and Business Management (AIESEC) is a completely independent, non-profit, non-political organization operating in over 71 countries around the world. We are devoted to developing global leadership. We accomplish this by arranging international internships for foreign nationals as well as our own general members.

To help our local committee grow and reach its potential, we are sending 5 members to a week-long National Leadership Seminar in Tucson, AZ. Our national committee requires us to send two delegates to the seminar including the LC President and Exchange Director. In addition we had the chance to select three general members for the trip. The two general members were interviewed and chosen from a field of ten based on their dedication to AIESEC and apparent leadership potential. Relatively young candidates were chosen so they would have a chance to share the knowledge they gain at this seminar with the other members of our LC. At the seminar the delegates will receive intensive training dealing with the development of their leadership and communication skills. The seminar will start on August 11 and go through August 19.

BILL SUMMARY

To allocate an amount not to exceed \$1,000 + GAR to help cover travel expenses incurred by AIESEC Colorado's four delegates to a National Leadership Seminar in Tucson, Arizona, scheduled to begin on August 11, 1991.

BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:

SECTION 1: To allocate an amount not to exceed \$1,000 + GAR to help cover travel expenses incurred by AIESEC Colorado's four delegates to a National Leadership Seminar in Tucson, Arizona, on August 11-19, 1991.

SECTION 2: A written report will be submitted pursuant to 24 ECB#4.


SECTION 3: This bill takes effect upon passage.



AIESEC-Colorado was fortunate to send five delegates to the National Leadership Seminar in Tucson, Arizona which is a conference to develop future leaders in the United States and around the world. UCSU funded \$1000 for the travel expenses of four of our delegates: Daniele Waldrop, Local Committee President, who was a chairperson for a subcommittee; Laura Granucci, Marketing Director, was a trainer; Jennifer Rousseau, Alumni Director, and Lewis Russell, Organizing Committee President, who were trained on the many aspects of leadership, commerce and internationalism within AIESEC. We also received \$300 from the Business Board used to cover travel expenses for another delegate, Joylyn Quintana, Marketing Assistant. Each student paid an additional \$290 for the conference delegate fee to help pay for accommodations and conference materials throughout the week.

The conference began on Monday describing the direction that our organization plans to follow over the next year called our Operational Direction Statement. Most of the day consisted of registration and activities to get to know fellow delegates. There were representing delegates from each of our regions across the United States(West, South, Central, and Northeast), as well as international delegates from Japan, Germany, Turkey, and England. Tuesday's theme was Resources and People in which we discussed, people being our greatest resource which we must utilize to its greatest capacity. On Wednesday we discussed our organizations long term financial stability and how we can improve this through more effective planning. The fourth day of our conference we were trained on AIESEC's product and improving the product in the eyes of the business community. On Friday we discussed the integration of our new international logo with our international exchange program. We matched our perception of AIESEC with the image we project to the business and campus community. The sixth day focused on our long term vision of AIESEC. On this day we talked about utilization and development of our peripheral support groups (i.e. Board of Advisors and Alumni.) Sunday, our final day of training included mock marketing calls and observation of and participation in the legislative process.

The knowledge we gained at this conference was brought back to train members of our local committee.
