A BILL

BILL HISTORY

Phi Delta Chi is a professional fraternity associated with the Pharmacy profession. The School of Pharmacy at Boulder represents the Sigma Chapter of the national organization. The Sigma Chapter was founded in February of 1914 on the Boulder campus and participates with 56 other Chapters in almost every pharmacy school across the country.

Phi Delta Chi serves an important role in the School of Pharmacy in several ways: It provides sources of information to Pharmacy students in terms of testing, specific teachers, and internships; furthermore, it enables Pharmacy students to reach common goals and interests that pertain to the practice of Pharmacy.

In terms of community service, Phi Delta Chi is valuable in providing public awareness on the correct utilization of prescription medication and is an important source of information for the public. The members have given presentations and answered questions on drug utilization in retirement homes. Phi Delta Chi is also active in participating with other organizations within the school of pharmacy such as in fundraising via a phone-a-thon and co-sponsoring the annual Christmas banquet, the beach party, awards convocation and the graduation commencement.

Phi Delta Chi also serves an important role in providing a social outlet for many pharmacy students which enables them to interact outside of the classroom in a relaxed manner.

Phi Delta Chi's 58th Annual Grand Council Meeting will take place July 28 thru August 2, 1991 at the Tremont Hotel in Baltimore, Maryland. Three members of Phi Delta Chi will represent the University of Colorado Sigma Chapter. At the meeting, the members will gain new ideas for service projects, recruitment of pharmacy students, fundraising and leadership skills. Also, the members will learn current information on new drugs and products and attend presentations and meetings on pharmaceutical issues and career opportunities in pharmacy. This meeting is a must for the survival as a chapter because according to Article V, Section 5, of the Phi Delta Chi National Constitution: "Any chapter failing to be represented by an active or an alumni delegate at two (2) consecutive Grand Council Meetings may be declared inactive and

it's charter forfeited and vacated".

BILL SUMMARY

BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:

SECTION 1: This bill allocates an amount not to exceed \$740.00 + GAR to help the Sigma Chapter of Boulder send three Phi Delta Chi representatives to Baltimore, Maryland in order to attend the 58th Annual Grand Council Meeting from July 28 to August 2, 1991.

SECTION 2: A written report will be submitted pursuant to 24LCB#4.

SECTION 3: This bill takes effect upon passage.


