**BILL HISTORY**

**SECTION 1:** That UCSU continues its support of diversity by funding Cultural Currents \$1,000 for its capital and production costs.

**SECTION 2:** A written report shall be submitted pursuant 24ECB#4.

**SECTION 3:** This bill takes effect upon passage.


