BILL HISTORY

NAGPS (National Association of Graduate and Professional Students) holds an annual conference in which graduate students from universities around the nation gather together to look at issues concerning graduate students such as health care, employment benefits, improving TA quality, etc. This conference also promotes the interactions between graduate students of various universities.

UGGS (United Government of Graduate Students) here at the University of Colorado plays an active role in NAGPS. Last year one of the five members of the executive board was from the University of Colorado. This year UGGS is prepared to make a strong bid for the national conference to be held in Boulder in Spring 1993. Hosting the national conference would be a great honor for UGGS and the University of Colorado.

Besides making a bid for next year's national conference, the delegates will have an opportunity to attend various talks including but not limited to: how to make a strong and efficient graduate student government and what graduate students can do to make a better university.

BILL SUMMARY

This bill allocates \$542.20 + GAR from the Council of Colleges and Schools account #1391200 to purchase two round trip tickets for students attending the annual the NAGPS conference in Washington D.C., March 12-16, 1992.

BE IT ENACTED by the Council of Colleges and Schools of the University of Colorado Student Union, THAT:

SECTION 1: This bill allocates \$542.20 + GAR from the Council of Colleges and Schools Account #1391200 to purchase two round-trip airline tickets for students attending the annual NAGPS conference in Washington, D.C., March 12-16, 1992.

SECTION 2: A written report will be submitted pursuant 34CCSB#15.

SECTION 3: This bill takes effect upon passage.


