BILL HISTORY

The Environmental Law Society is a Law School student group organized to advance awareness of and interest in environmental law and environmental issues at the Law School, on campus, and nationally. ELS sponsors speakers, coordinates political action through its Environmental Action Committee, and participates in national forums such as the annual Conference of Environmental Law Societies and various moot court competitions. The ELS is sponsoring a team of three of its members for participation in the 4th Annual National Environmental Law Moot Court Competition from February 20-22, 1991 in White Plains, N.Y.

The 4th Annual National Environmental Moot Court Competition is sponsored by the Pace University Environmental Law Moot Court Board and the Environmental Law Institute. The purpose of the competition is to develop expertise in environmental law appellate advocacy. The competition draws entries from around the nation. The University of Colorado School of Law is recognized as one of the top environmental law programs in the nation. Participation in this competition both increases recognition for the Law School and the university and enhances that reputation. This bill is a request for travel funding to this competition.

BILL SUMMARY
