BILL HISTORY

Phi Lambda Sigma Leadership Society is a professional organization designed to recognize students and practicing pharmacists for leadership contributions to the profession. The Alpha Xi Chapter of Phi Lambda Sigma was initiated at the University of Colorado School of Pharmacy in April of 1991 to recognize pharmacy leadership in Colorado. This is an organization that depends largely on student members for its operations and planning of annual events. One of these events includes planning and financing for the Phi Lambda Sigma Annual Meeting that will be held on March 14-18 in San Diego, California. Various activities including lectures, exhibit booths, and meetings will take place which are designed to promote leadership and enhance leadership skills. Several business items of Phi Lambda Sigma will also take place including the election of national officers. A delegate and alternate delegate are required from each chapter for participation in debate and voting on these issues.

BILL SUMMARY

The bill allocates an amount not to exceed \$750.00 + GAR from CCS account #1391200 to help send 4 student members of Alpha Xi Chapter of Phi Lambda Sigma to attend the Phi Lambda Sigma Annual Meeting in San Diego, CA from March 14-18, 1992.

BE IT ENACTED by the Council of Colleges and Schools of the University of Colorado Student Union, THAT:

SECTION 1: An amount not to exceed \$750 + GAR will be allocated from the CCS account #1391200 to offset round trip tickets from Denver to San Diego, CA to attend the Phi Lambda Sigma Annual Meeting.

SECTION 2: A written report will be submitted pursuant 34CCSB#15.

SECTION 3: This bill takes effect upon passage.
