BILL HISTORY

5 Phi Delta Chi is a professional fraternity associated with the profession of pharmacy. The School of Pharmacy at Boulder represents the Sigma Chapter of the national organization. The Sigma Chapter was founded in February of 1914 on the Boulder campus and participates with 56 other chapters in almost every pharmacy school across the country.

10 Phi Delta Chi's Annual Western Regional Meeting will take place February 14 thru February 17, 1992 at the Ramada Hotel in Anaheim, CA. Two members of Phi Delta Chi will represent the University of Colorado, Sigma Chapter. At the meeting, the members will gain new ideas for service projects, recruitment of pharmacy students, fundraising and leadership skills. Also, the members will learn current information on new drugs and products and attend presentations and meetings on pharmaceutical issues and career opportunities in pharmacy. This meeting is a must for our chapter because we will also be discussing on some Grand Council resolutions that pertain to our region.

20 This meeting is not only important for the Sigma Chapter but for the University of Colorado as well. There will be some prospective pharmacy students there, as well as future employers, and our presence can insure some active recruiting of students as well as demonstrating to employers that we are a campus of prospective employees.

SECTION 1: An amount not to exceed \$516.00 + GAR will be allocated from CCS account #1391200 for two round trip tickets from Denver to Anaheim, CA for the Phi Delta Chi Annual Western Regional Meeting.

SECTION 2: A written report will be submitted pursuant 3CCSB#15.

SECTION 3: This bill takes effect upon passage.


