A BILL

BILL HISTORY

One amendment to the UCSU Constitution proposed in 36 Executive Bill #1 would, in fact, remove one Representative at Large position in April 1992, if it passes in the Spring 1992 election. (This proposed amendment is Referendum #1 in the Spring 1992 election.)

5 The distribution of joint board positions among Representatives at Large is not addressed within 36EB#1. This issue must be decided as we remove a Representative at Large, since joint board positions are specifically enumerated in the UCSU Constitution.

10 The three boards with two voting members from the Representative Council are the Finance Board, the Cultural Events Board and the Student Health Board. All three of these boards use their two representatives well. While all boards make important and difficult decisions on a regular basis, these three are boards that
5 have issues more complex than other boards, justifying their usage of two Representatives at Large.

This bill proposes to remove one Representative at Large from the Cultural Events Board, adding one CEB member to be selected by the
20 Legislative Council. Such structure is parallel to other boards which have only one Representative at Large as a voting member.

While the CEB benefits from the "double coverage" given by Representatives at Large, it seems likely that both the CEB and the
25 Legislative Council would be less impaired by such a shift in membership than either the Finance or the Health Board.

BILL SUMMARY

30 The Legislative Council hereby directs the Election Commissioner to place the following question on the Spring 1992 ballot:

Do you approve of the amendment of Article III.H.1. of the UCSU Constitution to read:

35 "1. The Cultural Events Board shall include seven students.

a. One to be chosen by the Executive from the Representative Council. The choice must be approved by the Legislative Council.

- b. Three to be appointed by the Legislative Council.
- c. Three to be appointed by the Cultural Events Board with Legislative Council ratification."

This question shall only take effect upon passage if the proposed amendment to Article III.B.1. also takes effect. It would change one member of the Cultural Events Board from a Representative at Large to a Legislative Council appointment.

BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:

SECTION 1: The Legislative Council hereby directs the Election Commissioner to place the following question on the Spring 1992 ballot:

Do you approve of the amendment of Article III.H.1. of the UCSU Constitution to read:

- "1. The Cultural Events Board shall include seven students.
 - a. One to be chosen by the Executive from the Representative Council. The choice must be approved by the Legislative Council.
 - b. Three to be appointed by the Legislative Council.
 - c. Three to be appointed by the Cultural Events Board with Legislative Council ratification."

This question shall only take effect upon passage if the proposed amendment to Article III.B.1. also takes effect. It would change one member of the Cultural Events Board from a Representative at Large to a Legislative Council appointment.

SECTION 2. Should this question pass with a majority vote AND at least two thousand favorable votes, AND the referendum amending Article III.B.1 also meet these conditions, it shall take effect starting with the Thirty-Seventh Legislative Council Session.

SECTION 3: This bill takes effect upon passage.
