A BILL

BILL HISTORY

At the same time as we perform the amendments to create equal representation by Representatives at Large and Council of Colleges and Schools Representatives, we must update the CEB constitutional article to conform to a Regential Committee recommendation of 1986. At the time, the Regents suggested that the CEB be expanded to include nine student voting members, and two non-student voting members. Such an expansion was suggested to facilitate diversity and balance of experiences and philosophies on the CEB.

Due to confusion following the Fall 1986 election, this amendment was declared passed, though it actually failed. As a result, the CEB operates presently with nine voting members, with collusion of the Legislative branch. A fortunate result of this confusion is that we, as voting members of the UCSU, know in advance of passing this amendment that it is a successful way of increasing diversity and providing more stable membership and leadership on the CEB.

BILL SUMMARY

The Legislative Council hereby directs the Election Commissioner to place the following question on the Spring 1992 ballot:

"Do you approve of the amendment of Article VII.H.1. of the UCSU Constitution to add to the Cultural Events Board one more voting member to be selected by the Legislative Council, and one more voting member to be selected by the Cultural Events Board, both to be ratified by the Legislative Council. This would follow a 1986 recommendation of the University of Colorado Board of Regents."

BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:

SECTION 1: The Legislative Council hereby directs the Election Commissioner to place the following question on the Spring 1992 ballot:

"Do you approve of the amendment of Article VII.H.1. of the UCSU Constitution to add to the Cultural Events Board one more voting member to be selected by the Legislative Council, and one more voting member to be selected by the Cultural Events Board, both to be ratified

by the Legislative Council. This would follow a 1986 recommendation of the University of Colorado Board of Regents."


SECTION 2: Should this question pass with a majority vote AND at least two thousand favorable votes, it shall take effect starting with the Thirty-Seventh Legislative Council Session.

SECTION 3: This bill takes effect upon passage.




