A RESOLUTION

- Whereas: On 27 November 1991, the University of Colorado Board of Regents announced that an informational panel discussion would take place at their 19 December meeting to discuss the inclusion of "sexual orientation" in the antidiscrimination clause of the Laws of the Regents; and
- Whereas: The student representational bodies of the other three CU campuses have or are in the process of drafting resolutions strongly supporting such inclusion; and
- Whereas: The University of Colorado Student Union Legislative Council passed a strongly-worded measure, 34LCB#1, in support 15 November 1990; and
- Whereas: The University of Colorado Student Union voted 3504-304 to include "sexual orientation" in its own documents, by adding Article XVIII to its Constitution in April 1990;

THEREFORE BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE UNIVERSITY OF COLORADO STUDENT UNION, THAT:

- SECTION 1: The University of Colorado Student Union Legislative Council reaffirms all provisions of 34LCB#1.
- SECTION 2: The University of Colorado Student Union Legislative Council condemns any discrimination on the basis of sexual orientation.
- SECTION 3: The University of Colorado Student Union Legislative Council maintains a persistent commitment to this issue.

SECTION 4: This resolution takes effect upon passage.

UCSU REFERENDUM QUESTIONS

1. Article VIII of the constitution shall be stricken and replaced with:

A. Commissions and Student Administrators shall be established by the Executive with majority approval of Legislative Council.

- a. Legislative Council may establish Commissions or Student Administrators by a 2/3 vote.
- b. Each Commissioner and SA shall be appointed by the Executive and ratified by majority vote of Legislative Council.

2. UCSU shall not discriminate on the basis of creed, race, gender, age, sexual orientation, or political orientation.

Spring

- o UCSU shall pass no legislation aiding a sectarian organization.
- o UCSU shall pass no legislation abridging the freedom of press, and/or free speech.
- UCSU shall pass no legislation abridging the right of its' members to petition UCSU for a redress of grievances.
- o The enumeration of certain rights in the UCSU Constitution shall not be construed to deny or disparage others held by the student body.
- o All powers not delegated to the UCSU government are reserved to the student body.

3. We, the fee paying students of the University of Colorado, at Boulder support the freedom of every woman, regardless of age, economic, or marital status, to make her own decisions about her body. It is therefore the official position of the fee paying students to support the access of every woman to a safe, legal, abortion to the full extent allowed under the U.S. Supreme Court case of <u>Roe v.</u> <u>Wade</u>. We further support the position that the state of Colorado place no restrictions on this right.

UCSU shall pursue this policy by and through the executive and legislative branches including, but not limited to the following actions:

a. Health board shall investigate student health insurance that includes coverage of gynecological services for each fiscal year beginning fiscal 1991.

b. Letters shall be sent (within two weeks of passage of this policy) to State Representatives, the Board Delegation, and the President of the United States urging active implementation of the policy.

c. An executive of the UCSU shall present this policy to th Colorado Student Association, and the United States Student Association.

d. This policy shall be considered a priority of the executive staff.

e. The President Pro-Tempore of Legislative Council and the Executives shall submit guest editorials to all campus papers each fall and spring semester delineating the actions that have been taken to implement this policy.

f. This policy shall be prominently displayed in the UCSU office.

g. Upon passage this policy shall be binding.

4. Shall UCSU assess the students of the University of Colorado, Boulder, \$.30 per semester for the next four years, as part of student fees, to fund the Unified Government of Graduate Students, for the promotion of graduate student affairs?

5. Do you support the reinstatement of budgetary cuts from the Women's Health Care Clinic at Wardenburg Student Health Services in the event that these cuts are approved by UCSU? A student fee of \$.39 per student per semester will be assessed contingent upon the cuts being made from the Women's Health Care Clinic.

6. Do you support the reinstatement of budgetary cuts from the Psychiatry Clinic at Wardenburg Student Health Services in the event that these cuts are approved by UCSU? A student fee of \$3.93 per student per semester will be assessed contingent upon the cuts being made from the Psychiatry Clinic.

7. Would you be willing to add \$.75 per semester for two years to your student fees to help offset the Campus Press production costs, thereby reducing dependency on advertising revenue?
