BILL HISTORY

The National Association of Student Personnel Administrators has produced a teleconference entitled "Understanding & Meeting the Needs of Gay, Lesbian, and Bisexual Students". This national teleconference is to be broadcast at CU-Boulder on February 6, 1992. Counseling and Career Services, a Multicultural Center, is arranging for CU-B faculty, staff and students to provide a brief overview of the local perspectives, where local panelists speak before and after the actual teleconference broadcast.

Topics that will be discussed are the significant development issues for gay, lesbian and bisexual students; responsibilities toward gay, lesbian and bisexual students; the impact of homophobia on individuals and on the campus community; how the campus should address incidents of harassment, discrimination or violence.

The presenters of this teleconference are:

Kevin Berril, a native of Connecticut, is a graduate of Vassar College. He is the Director of the Campus and Anti-Violence Projects of the National Gay and Lesbian Task Force in Washington, D. C. This Task Force is the leading national gay and lesbian civil rights advocacy and public education organization. Mr. Berril initiated the Task Force's Campus Project in 1987. He is a frequent lecturer at colleges and universities on the topics of anti-gay violence and victimization.

L. Lee Knefelkamp, Professor and Chair of the Department of Adult and Higher Education, Teachers College/Columbia University. Dr. Knefelkamp is a renowned professor, practitioner, consultant, speaker and author with expertise in student development theory and practice, women in higher education, learning environments, teaching and administration.

Kathy Obear, President of The Human Advantage, a human resources management firm specializing in employee development seminars and worksite wellness programs. She is currently a doctoral candidate at the University of Massachusetts-Amherst and is a frequent speaker on the topics of management and leadership, value differences, homophobia and heterosexism.

James E. Washington, a doctoral intern in the Office of the Vice President for Student Affairs at the University of Maryland-Baltimore County. Mr. Washington is committed to addressing issues of oppression for all people and conducts workshops in the areas of racism, sexism, heterosexism/homophobia, and developing successful multicultural communities.

Rosalind E. Andreas is Vice President for Student Affairs at the University of Vermont. Dr. Andreas was the founding chairperson of the ACPA Commuter Programs Commission, has served on the NASPA Journal editorial board and has written on the topics of student leadership programs, commuter students, and Institutional planning.

BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, **THAT:**




