The University of Colorado Chapter of the Collegiate Music Educators National Conference (UC-CMENC) is an organization comprised primarily, but is not limited to, Undergraduate Music Education Majors from the College of Music. Esteemed members from the UC-CMENC include Hugh E. McMillen - founder of the Colorado Music Educators Association; Kevin Mccarthy - past president of the Colorado Music Educators Association; Willie Hill - renowned Jazz performer, lecturer, composer, author.

Local activities of the UC-CMENC include service projects such as teaching music classes at the Boulder County Safehouse; hosting an ongoing guest lecture series; and sponsoring an annual recital competition which recognizes outstanding performers from the College of Music. The UC-CMENC sends representation to the Colorado Music Educators Association Convention in Colorado Springs annually to expose the current Music Teaching profession to the ideals and suggestion of the upcoming members of the profession.

The Music Educators National Conference will be holding its National Convention in New Orleans on April 8-12, 1992. The UC-CMENC will be sending five representatives to the convention.
