BILL HISTORY

On April 24, 1991, UCSU, Greek Council and the Peer Educators sponsored a program on the issue of drinking while intoxicated and the implications of this issue relating to the CU student population.

Last year's event, titled "See Dick and Jane Drink", was considered a great success due to "standing room only" in the Forum Room. Last year's speakers included Judge Marcia Yeager, Officer John McGregor, District Attorney Cathy Degado, Professor Jim Wilson and DARE to Stop Rape volunteers. The speakers all provided valuable information on many aspects of drinking. Most notably, Officer John McGregor provided roadside impairment tests (DUI tests) on two students ("Dick and Jane") who volunteered to demonstrate the temporal effects of alcohol and how alcohol affects one's driving ability. Last year UCSU funded \$317.26 + GAR for advertising purposes and we hope to continue the support.

This year we are looking to put on the "Dick and Jane" program on April 6, 1992 in Chem. 140 with much of the same format. This was such a successful program last year that we see no reason to change the format. This year we will continue our outreach to residence hall students, Greek members and the student body as a whole.

The most important aspect of this event is the fun educational experience people gain about responsible alcohol consumption, particularly as relating to driving under the influence. This year's "Dick and Jane" program is being sponsored by the Peer Educators, the Greek Council.
