BILL HISTORY

In the Constitution of the CU Ultimate Team it states that our main purpose is to promote the sport of Ultimate. The Ultimate Players Association (UPA) is an international organization lead and run by thousands of players dedicated to this nonprofit organization. Because the organization is as young as the sport itself (Ultimate was invented in 1968) it has turned its eyes to the youth to make it grow. The Western Regional tournament is a UPA sanctioned event, and will be hosted by the University of California, Davis at Sacramento (UCD). Two teams will be permitted to represent the Rocky Mountain Section at this tournament, and the CU Ultimate team would like to be one of them.

The Western Region is currently the toughest in the country with University of California, Santa Cruz being the current National Champions. Although a newly formed intercollegiate club team, we have recruited several experienced players, as well as a nationally ranked player to be our coach and anticipate a very successful season. Our scheduled practices begin at the first of next semester, and will continue throughout the season. To date we are scheduled to compete in six tournaments during the course of the season excluding Sectionals (to be hosted by our team in early April), Regionals, and Nationals.
