A BILL

BILL HISTORY

The University of Colorado Student Union has been an active member of the United States Student Association (USSA) for several years (excluding 1988-89). UCSU has been a fee paying member since 1984, and has had the honor of hosting the National Student Congress in 1985. On July 20, 1989, the UCSU Legislative Council voted to support the Colorado Student Association (CSA) joining USSA. The CSA became an official member nine days later, giving CU Boulder eight official delegates to USSA's National Student Congress. On April 9 & 10, 1991, CU voted to directly fund CSA through a referendum question (3750-1437). This funding was, and still is, contingent upon CSA's active participation in USSA. On April 13-15, 1992, students at CU Boulder voted to directly fund the United States Student Association (in addition to CSA) by paying 50 cents per student per semester (2218-1204).

USSA's annual National Student Congress is a gathering of all campuses which are USSA members, as well as many non-member schools. USSA policy-making and goal-setting for the academic year is decided upon in addition to elections of new USSA national officers and Board of Directors (the UCSU Legislative Council met both the USSA President and Vice President as well as having two CU Boulder students be on the Board of Directors). CU has a long history of sending students to USSA congress'--we have sent delegates for the past five years. This year, the National Student Congress will be held August 4-10 in Washington, D.C.

BILL SUMMARY

This bill allocates an amount not to exceed \$720.00 plus GAR from Legislative Council account #1391120 to send UCSU representatives as official delegates to the 1992 United States Student Association National Congress in Washington, D.C., August 4-10.

BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:

SECTION 1: An amount not to exceed \$720.00 plus GAR shall be allocated from Legislative Council account #1391120 to cover partial costs of sending UCSU representatives to the 1992 National Student Congress.




