BILL HISTORY

2 The Hispanic Law Student Association would like to invite Mr.  
3 Federico Pena and Ms. Dolores Atencio to speak to the Law School  
4 and other interested students at the University of Colorado on the  
5 impact of the North American Free Trade Agreement.

6 Mr. Pena is the former mayor of Denver and has had a strong input  
7 in the negotiations which have led to the current NAFTA proposal.  
8 Mr. Pena is now a member of Hyatt, Brownstein, & Farber. He heads  
9 their international business counsel department. Mr. Pena would be  
10 able to impart useful and important insights into what will be a  
11 very influential agreement.

12 Ms. Dolores Atencio, former President of the Colorado Hispanic Bar  
13 Association, is currently an associate attorney with Pryor, Carney  
14 and Johnson. Ms. Atencio has met with Mexico's President Salinas  
15 to discuss NAFTA. Her knowledge of the proposed agreement will  
16 help students obtain valuable information of what will be a far-  
17 reaching international agreement.

18 These two individuals can help to give students at the University  
19 insights into the advantages and problems which the agreement will  
20 raise. Many students graduating will be benefitting under the  
21 agreement. Understanding the goals and working of NAFTA will allow  
22 students to structure their education necessary to work within the  
23 unified markets.

24 The Hispanic Law Student Association would greatly appreciate the  
25 Legislative Council's assistance in producing this opportunity to  
26 inform the University of Colorado students with current and  
27 important information. Our organization has very competent and  
28 motivated individuals who are willing to put forth the time and  
29 energy to make this a successful presentation.

BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:

**SECTION 1:** This bill allocates an amount not to exceed \$861.00 plus GAR from Legislative Council account #1391120 to bring Mr. Federico Pena and Ms. Dolores Atencio to the UCB campus on October 22, 1992 to discuss NAFTA.

**SECTION 2:** Written reports and editorials shall be submitted pursuant 36LCB#20.
