## BILL HISTORY

The Hispanic Law Student Association would like to invite Mr. Federico Pena and Ms. Dolores Atencio to speak to the Law School and other interested students at the University of Colorado on the impact of the North American Free Trade Agreement.

6 Mr. Pena is the former mayor of Denver and has had a strong input in the negotiations which have led to the current NAFTA proposal. 8 Mr. Pena is now a member of Hyatt, Brownstein, & Farber. He heads their international business counsel department. Mr. Pena would be 10 able to impart useful and important insights into what will be a very influential agreement.

Ms. Dolores Atencio, former President of the Colorado Hispanic Bar
Association, is currently an associate attorney with Pryor, Carney
and Johnson. Ms. Atencio has met with Mexico's President Salinas
to discuss NAFTA. Her knowledge of the proposed agreement will
help students obtain valuable information of what will be a farreaching international agreement.

20 These two individuals can help to give students at the University insights into the advantages and problems which the agreement will 22 raise. Many students graduating will be benefitting under the agreement. Understanding the goals and working of NAFTA will allow 24 students to structure their education necessary to work within the unified markets.
