BILL HISTORY

INVST (International and National Volunteer Service Training) is a student program for promoting social, economic, and environmental justice. The core of the INVST program is to provide experiential learning through service learning in a college setting.

6 The "Seeds of Change" Conference is the sixth annual conference of the National Student Campaign against Hunger and Homelessness. An 8 emphasis of the conference is to augment community service with long-term and holistic solutions to hunger and homelessness. Jesse 10 Jackson and Carol Fennelly (Committee for Creative Non-Violence) will be speaking and Jimmy Carter has been invited and not yet 12 confirmed.

14 The "Seeds of Change" Conference is an ideal opportunity for our group to both share our INVST experiences with others, as well as 16 hear other perspectives on how to best fight against the problems of hunger, homelessness, and other social injustices.

By limiting the numbers of our group who would attend the conference to the bare minimum necessary for presenting a workshop, we have made every attempt to limit the expenses of this trip. We are asking Legislative Council for \$1290.00 plus GAR for the costs of travel for 5 attendees.
