A BILL

BILL HISTORY

The American Institute of Architecture Students (A.I.A.S.) is a national student run organization devoted to enlarging its chapter member's understanding of the current and future scope of architectural practice. The group also encourages interaction among students, architectural educators and practitioners.

During thanksgiving week, (Tuesday November 24-28) A.I.A.S. Nationals is having a Forum in Buffalo, New York. Forum is the national convention of the American Institute of Architecture Students. Held annually during Thanksgiving week, Forum provides students with the opportunity to learn, to meet new people with common interests, and to communicate with other students and practitioners concerning education and professional development.

Since, 1968, Forum has grown to become the largest activity sponsored by A.I.A.S.. Each forum program is centered around a theme selected by the host school, which happens to be in Buffalo this year. Forum events include workshops and seminars led by prominent architects and major resource people in the architectural field. These sessions enable students and professionals, both in academic and business worlds, to discuss the relevant issues facing the architectural profession today.

I am writing in regards to obtaining money for this event since there are two students interested in attending this year. As the A.I.A.S. President, I am required to go. The budget for registration, hotel, food, and transportation is \$638.46 per person.

BILL SUMMARY

This bill allocates an amount not to exceed \$836.92 + GAR from Legislative Council account #1391120 to partially fund travel expenses for the American Institute of Architecture Students to the National Forum in Buffalo, New York on November 24-28, 1992.

BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:

SECTION 1: To allocate an amount not to exceed \$836.92 + GAR from Legislative Council account #1391120 to fund expenses for the American Institute of Architectural Students to the National Forum in Buffalo, New York on November 24-28, 1992.
