BILL HISTORY

The International Association of Students in Economic and Business Management (AIESEC) is a completely independent, non-profit, non-political organization operating in over 71 countries around the world. We are devoted to developing global leadership. We accomplish this by arranging international internships for foreign nationals as well as our own general members.

To help our local committee grow and reach its potential, we are sending 4 members to a week-long National Leadership Seminar in Seattle, WA. Our national committee requires us to send two delegates to the seminar including the LC President and Exchange Director. In addition we had the chance to select three general members for the trip. The two general members were interviewed and chosen from a field of ten based on their dedication to AIESEC and apparent leadership potential. Relatively young candidates were chosen so they would have a chance to share the knowledge they gain at this seminar with the other members of our LC. At the seminar the delegates will receive intensive training dealing with the development of their leadership and communication skills. The seminar will start on August 10-17, 1992.


