BILL HISTORY

During the April 1991 elections UCSU became a member of the United States Student Association (USSA) by virtue of the student vote to 2 become members of the Colorado Student Association. Accordingly, UCSU sent a delegation of eight to USSA's National Congress, held 4 in Milwaukee, Wisconsin, August 12-18. At the Congress, Ms. Wagman Wagman was elected to the National Board of Directors, which meets 6 five times during the year between National Congresses, to set priorities for action and direct the nation's largest student 8 organization. As one of Colorado's members of the Board, Katie provides a voice for the students of CU-Boulder in determining the 10 course of USSA and the work done on education issues in the 12 nation's Capitol.

The first Board of Director's meeting will be held May 22-24 in Atlanta, Georgia at the national office in USSA. Attending this meeting will give Katie the opportunity to voice unique concerns to the national board, as well as give her the chance to gather more information about USSA and determine how it can best benefit CU. Ms. Wagman will be paying for her own ground transportation, meals, as well as lodging. Katie Wagman requests the Council of Colleges & Schools provide her airfare of \$239.85 + GAR.
