## A BILL

#### BILL HISTORY

Over the last eighteen months the political situation in Somalia has degenerated into anarchy. Urban centers are 'hostage' to the whims of armed 'gangs' that have found along clan lines. Rural Somalia is similarly afflicted, and on-going civil war has disrupted agricultural activity by peasants and led to massive displacement of the rural population. Somalia is also subject to the four year drought that is affecting the horn of Africa as a whole. The overall effect of these combined crises is a famine/food shortage of appalling proportions.

Relief organizations have put the number of those at risk of immanent starvation at 1.5 million. An estimated 25% of all children under the age of 5 have died this year, as a recent Oxfam report put it "an entire generation could perish". Some 300,000 Somalis have fled to neighboring Kenya and thousands flock to major cities seeking food, all these people are now dependent on food aid. Somalia is certainly the worst human tragedy of this year, and quite possibly of the decade. It is unacceptable that a catastrophe of this magnitude pass without comment and unnoticed on this campus.
