A BILL

BILL HISTORY

Delta Sigma Pi is a coed professional fraternity organized to foster the study of business in Universities. The fraternity was founded in 1907 and the Alpha Rho chapter, at the University of Colorado, was founded in 1926. Since that time, here at CU, we have become one of the largest chapters in the nation and one of the most recognized in the business school. In 1990 we were recognized as the most outstanding chapter in the nation and in 1992 we were once again voted an honor as most outstanding in the region. In 1993 we would once again like to bring recognition to the University of Colorado as most outstanding in the nation.

In lieu of our goal, and in light of the honors we have already received, the Alpha Rho Chapter is hosting a state wide conference on March 6-7, 1993. This conference is an opportunity for other schools around the state to see our campus and how our chapter runs and vice versa. All day there will be seminars, workshops, and key note speakers on leadership, business, and today's working environment. The participating delegates will benefit from these activities which are designed to be a venue for carrying back information to the various schools and universities. We hope that this will be an opportunity for everyone to see why the University of Colorado has one of the leading business schools in the nation.

BILL SUMMARY

This bill shall allocate \$600.00 plus GAR from Council of Colleges and Schools account #1391200 to the Alpha Rho Chapter of Delta Sigma Pi for a statewide Conference hosted at the University of Colorado on March 6-7, 1993.

BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:


**Ladies and Gentlemen:**



## Alpha Rho Chapter

To the Representatives of the C.C.S.:

I would like to express my disappointment in not having the funding bill for Colorado Conference passed at last week's meeting. It was a big financial setback to the Conference, and of course, discouraging to myself and Delta Sigma Pi. After putting in over 100 hours of work raising money, recruiting speakers, planning events, and visiting colleges around the state, only to have your bill defeated is very disheartening. I was informed that the primary reasons for the bill's failure, were the GPA requirement of our group and the two to one vote margin, in which five representatives abstained. Which brings me to the purpose of this letter. First, to address some of your concerns about Delta Sigma Pi. And second, to express some of our concerns with the actions of U.C.S.U.

We are a non-profit, co-ed, multinational, professional organization that benefits its membership through professional and community service activities. Over the last ten years Alpha Rho Chapter participated in over 70 events and has given over \$30,000 in community support and service. We bring in more than 15 speakers a semester, more than Business Board or any other club, and all our activities are open to the entire student body. It is because of this work with the community and University, that our chapter was honored as being the most outstanding chapter in the nation.

One of the national requirements of our professional fraternity is to maintain a minimum GPA. This regrettably, must be followed for us to maintain our charter at C.U. Even with this limitation however, we have become the largest organization of any kind at the College of Business representing 139 students, two Deans, and ten faculty members this semester alone. We have ten members on Business Board, five on Leadership Council, and over 60 involved in other clubs. We represent a large and diverse group of individuals, and it is for this reason that we feel our GPA requirement shouldn't be used to deny us access to student funds.

The second reason for our dissatisfaction is the lack of professionalism displayed by U.C.S.U. Our primary concern was the changing of our bill's hearing place and time on the very night it was to be heard, and second by not informing me or any of the 80 members who were to be in attendance of this occurrence, and thereby not allowing us to represent our own bill. If our bill is to be moved to a different legislative body and at a different time, we should know about it. It is a common courtesy when something as important as \$750 is requested, that the group requesting it should be informed of any changes. By not informing us, we were effectively not allowed representation either to speak on our behalf or to answer any concerns. It is Delta Sigma Pi's feeling that on those grounds, we should be able to resubmit our bill for consideration.

On behalf of Delta Sigma Pi, Alpha Rho Chapter, I would like to thank you very much for your time. I would hope that you will consider this letter and the students whom this organization represents in making your decision.
