BILL HISTORY

On March 21, 1991 the UCSU Legislative Council passed 34LCB#23 which called for the creation of a Greek Concerns Joint Task Force. The Task Force was to be convened by May of 1991 in order to address issues of controversy surrounding the role and social consequences of the Fraternity and Sorority system at CU-Boulder. Membership of the Task Force was to consist of representatives from IFC, Panhellenic Council and various student groups and organizations.

The Task Force was created by the Legislative Council in reaction to a number of specific incidents during the 1990-91 school year. The Task Force, which was to last for one year, was never convened.

This entire incident placed a great deal of strain not only on UCSU's relationship with the Greek System but also between Greeks and non-Greeks throughout campus.

BILL SUMMARY

This bill shall create a Greek Issues Task Force as a proactive mechanism to handle and resolve similar conflicts when and if they arise in the future.

---

BE IT RESOLVED by the Legislative Council of the University of Colorado Student Union, THAT:

SECTION 1: The purpose of the Task Force shall be to negotiate and mediate between the parties involved and ideally reach a resolution to the conflict or incident. The Task Force shall be empowered to make recommendations to the appropriate body (i.e. UCSU Legislative Council, IFC, Panhellenic, Office

SECTION 3: Membership of the Task Force shall include: 2 student appointments from IFC; 2 student appointments from Panhellenic Association; 2 student appointments from UCSU Legislative Council; 1 UCSU Executive; the UCSU Greek Liaison; and student appointments from Black Greek Council. At the discretion of the Task Force, additional student members who have a direct link to the incident may be added as members, with the Task Force's total number of members not to exceed 12. The UCSU Greek Liaison shall act as Chair of the Task Force. If the UCSU Greek Liaison is not available then the Task Force shall elect one of its members to the Chair.


SECTION 4: The Task Force shall determine: its meeting schedule; the length of time which it will remain convened to deal with any incident; and if any outside assistance is necessary for the mediation process.

SECTION 5: This bill supersedes 34LCB#23.

SECTION 6: This bill takes effect upon passage.
