## BILL HISTORY

The Sixth Annual National Public Interest Law Career Fair is being held on October 29, 1993 in Silver Spring, Maryland. These annual career fairs are a unique and vital source of information and contacts for law students who desire to enter into public service law. There will be representatives from over one hundred and fifty national organizations discussing job openings and giving advice and information on how to enter and pursue a career in public service law. Organizations present will range from the National AIDS Legal Action Network to the Wilderness Society. There will be workshops conducted throughout the duration of the fair aimed at helping student pursue public interest careers. Student representatives from over 125 law schools attend annually.

Participation in this event will advance the interest of the students of the University of Colorado in several ways. representatives from CU School of Law will be able to further the name of the school as one which is actively committed to public service law and therefore encourage these employers to actively recruit CU graduate students both on and off campus. Additionally, CU organizations which will greatly assist CU students looking for Summer and fulltime post-graduate employment. Participation in this Fair will enable CU to further implement its Loan Forgiveness Program for Public Service through discovery and procurement of additional grant sources. Finally this fair will enable CU student representatives to work with the faculty and administration to create the changes we need in the curriculum to better prepare our students for careers in the public interest sector. Interest Student Association (PISA) is currently negotiating with the Dean of the School of Law for funds to match those we raise The Law School Career Services office has already from UCSU. funded the \$80.00 registration fee. The remaining primary cost for attending is plane fare, hotel and traveling expenses. Therefore, we are requesting \$600.00 of student union funds from UCSU to help us attend the Sixth Annual Fair.
