**BILL HISTORY**

2 The Asian American Law Students Association (AALSA) is an  
3 organization for law students interested in issues that Asian  
4 Americans face, especially in the practice of law. We try to  
5 educate others of the different philosophies that minorities, and  
6 in particular, Asians, have. We also work with the Law School  
7 Administration to increase the diversity of the law school by  
8 recruiting and encouraging Asians to attend CU Law.

10 AALSA would like to send two of its officers to the National Asian  
11 and Pacific American Law Students Association (NAPALSA) Conference.  
12 This conference is in Chicago, IL during the weekend of October 22-  
24, 1993.

14 The focus of this year's conference is "Shattering the Paradigm -  
15 Charting a New Course". Of special interest is the workshop on how  
16 to increase enrollment of Asians at law schools, especially in the  
17 Mountain and Midwest regions. In the past three years, CU Law has  
18 had an enrollment of only two Asians in each of its entering  
19 classes. This number represents less than two percent of the class  
20 and has decreased from previous years enrollment. This conference  
21 will allow us to interact with people from other schools which have  
22 strong Asian enrollment and learn how they attract students to  
23 their schools.

**BILL SUMMARY**

26 This bill requests \$650.00 (representing two airline tickets, two  
27 nights lodging, and ground transportation) from Colleges and  
28 Schools account #1391200 to help fund travel to the NAPALSA  
29 Conference in Chicago, IL in October 22-24, 1993.

34 **SECTION 1:** This bill requests \$650.00 + GAR or the cost of two  
35 airline tickets, two nights lodging, and ground  
36 transportation from Council of Colleges and Schools  
37 account #1391200 to help fund travel to the NAPALSA  
38 Conference in Chicago, IL in October 22-24, 1993.

40 **SECTION 2:** A report shall be submitted pursuant to 34CCSB#15.

**SECTION 3:** This bill takes effect upon passage.


