A BILL

BILL HISTORY

The CU Chinese Student and Scholar Association (CU-CSSA) was organized to represent more than 200 students and scholars from People's Republic of China at CU. This organization has been actively participating in the social and culture activities on CU campus and Boulder city to promote culture diversity.

The Independent Federation of Chinese Students and Scholars (IFCSS) was founded soon after Tian-An-Men Massacre in 1989 and has been the sole independent chinese students organization in the United States to represent the interests of Chinese students, promote democracy in China, and promote mutual understanding between Chinese people and people in USA. As the Chinese students organization from at CU, the most influential university in this region, and a constituent of IFCSS, the CU-CSSA also has been actively involved in the activities of Chinese students in the whole United States.

The CU-CSSA has been invited to send a delegate to take part in the IFCSS 5th Congress. The Congress will be held at University of Kentucky at Lexington, KY on July 2-5. In this Congress, the new Chairperson and Legislative Council of IFCSS will be elected and the course of the coming year discussed. We believe that the participation of the congress is essential for determining the future of the IFCS and the experiences and the cooperation skills that a student organization gained from the interactions with other student organizations are also very beneficial for us.

BILL SUMMARY
