BILL HISTORY

The Round Table Dinner is an attempt to bring together different constituents including but not limited to graduate students, undergraduate students, faculty, staff, administrators, community leaders and state leaders to discuss topics of importance to the University of Colorado at Boulder and the surrounding community.

Previously the Round Table Dinner has consisted of three main parts. First, there is a cocktail hour in which everybody has the 8 opportunity to meet everybody else in an informal setting. Second, a dinner is served at which the discussions occur. In the past 10 there have been approximately 12 separate tables with five to eight people at each table which includes a moderator who leads the .2 Each table is given a separate topic to discuss. discussions. 14 Furthermore, each table is represented by as many different constituents as possible. Finally, after the dinner each moderator prepares a written statement. The packet of summaries are sent to 16 all participants of the Round Table Dinner and other interested 18 parties.

20 There are several ways that the Round Table Dinner can help the University of Colorado. Discussions can lead to direct suggestions 22 which can be immediately implemented. Also, these discussions can form seeds of thought which over time will grow into a committee or 24 a policy. Finally, the Round Table Dinner establishes basic communication ties between various constituents which are needed to 26 solve any number of countless problems.

It is important to note that the Round Table Dinner is not a group of committees. Rather, the Dinner is a brainstorming session which could either lead to a committee formation or give input to an established committee. Even though the Dinner should not be considered a committee, the table members should be knowledgeable about their topic, and the members will also have different viewpoints. The suggestions made during the Dinner should then be given to the appropriate people (who could very well be table members) for further discussion or action.
