## A BILL

## BILL HISTORY

The National Association of Graduate and Professional Schools (NAGPS) has two main purposes. First, it represents the interest of graduate and professional students at the federal level. Second, NAGPS acts as a clearinghouse of information about various programs at other institutions. If the University of Colorado wanted to put on a research fair, we could ask NAGPS for a list of other member schools that have research fairs and for any information in the National Files concerning these research fairs. In other words, with NAGPS, we would not have to learn how to make the wheel. Rather, we could readily find out from other graduate organizations.

The United Governments of Graduate Students has a very productive relationship with NAGPS. For the past three years, a member of UGGS has been an officer in NAGPS. Also, last year, the Annual National Conference was held in Boulder. Currently, UGGS is a very highly respected graduate student organization in NAGPS.

The bill asks for funds for a third person to go to the NAGPS Conference. At this conference, national policy will be set. Furthermore, the participants will be able to network with graduate students at other graduate institutions. Also, one participant is scheduled to give a presentation at the conference. By sending three people, the University of Colorado will remain one of the more respected schools attending the conference.
