BILL HISTORY

2 The University of Colorado at Boulder is honored to have many  
3 talented students representing CU in competition around the  
4 country. These competitions are an opportunity for CU students to  
5 demonstrate our skills and talents, as well as give good PR for the  
6 school. Anjanette Brandon, a talented vocal performer in the  
7 College of Music, has been awarded the honor of representing CU in  
8 the 1994 American Traditions Competition. This event is a musical  
9 competition which celebrates diverse forms of musical expression.

10 The American Traditions Competition will take place from February  
11 25-March 7, 1994 in Savannah, Georgia. There will be well known  
12 celebrities from around the country judging the competition. This

28 of Colleges and Schools account #1391200 to help  
29 fund travel & lodging accommodations for a student  
30 to attend the 1994 American Traditions  
31 Competitions, February 25-March 7 in Savannah,  
32 Georgia.

33 SECTION 2: Written reports and editorials shall be submitted  
34 pursuant to 34CCSB#15.

35 SECTION 3: This bill takes effect upon passage.
