A RESOLUTION

WHEREAS: The UCSU and all of it's branches are based upon an ethic of mutual trust and understanding.

WHEREAS: In 1985, this ethic was expanded to include the administration of CU-Boulder by the adoption of the Chancellor/UCSU Autonomy Agreement and Protocols.

WHEREAS: According to the Chancellor/UCSU Autonomy Agreement and Protocols, the UCSU and the CU-Boulder administration are equal partners in administrative and financial matters concerning student fees.

WHEREAS: The UCSU, according to the Autonomy Agreement, has equal power in matters concerning classified staff of UCSU Cost Centers (Wardenburg, University Memorial Center, Recreation Center, Cultural Events Board, Legal Services, Off Campus Student Services, Volunteer Clearing House, KUCB, and the Environmental Center) with CU-Boulder administration.

WHEREAS: UCSU recognizes individuals in Central and CU-Boulder Administration have violated this agreement by threatening the job security of UCSU/State employees solely on the basis of their exercising their right to free speech and freedom of expression.

WHEREAS: UCSU recognizes these employees actions are officially sanctioned and approved of by the UCSU Legislative Council and Executives, both past and present via past approval of the Wardenburg Student Health Center 5-Year Strategic Plan and the WSHC Program Plan.

BE IT RESOLVED by the Legislative Council of the University of Colorado Student Union, THAT:

SECTION 1: The UCSU reaffirms it's equal status in matters of hiring and firing of it's classified staff as per the Autonomy Agreement dated December 13, 1985.


SECTION 2: The UCSU Legislative Council and Executives still uphold their support for past actions of the Wardenburg Student Health Center administrators concerning CU-Plus/UMGP and WSHC.

SECTION 3: The UCSU Legislative Council and Executives uphold their support for all actions taken by the Wardenburg Student Health Center Director that are in accordance with the WSHC Program Plan approved by the Legislative Council, and with UCSU official policy.

SECTION 4: A copy of this resolution will be sent to the Vice Chancellor of Student Affairs Office, the Chancellor's Office, the Office of Affirmative Action and Human Services, the President' Office and to all members of the Board of Regents.

SECTION 5: This resolution takes effect upon passage.
