**Bill history**

Colorado Crew is a student group that competes in the Mid-West in regattas held throughout year. We race against schools from the Big Twelve and the PAC-10. Crew is student run and comprised of university students, is governed by a constitution and follow all rule set forth by UCSU. This funding is to be used for transportation, lodging and operating costs of Colorado Crew. This includes, but is not exclusive to, bus service, gasoline costs, towing and transportation costs of our boats, hotel and lodging costs, and food while on official team trips. This funding is also to be used for the costs of photocopies, including but not limited to, team handouts used in recruitment, team meetings, public relations packets and other mailings. Included in operating costs are also yearly fees paid to the Boulder Reservoir the Rocky Mountain Rowing Club, USRowing, the Western Intercollegiate Rowing Association, boat storage costs, gasoline for daily practice, and other misc. items used for daily administrative, and logistical operations. This funding is not to be used to purchase equipment or spare parts. This includes racing shells, oars of any type, launches, and motors, and all spare parts exclusive to their use and operation. Funds are also not to be used for the purchase of fundraising materials for the team, including but not exclusive to raffle tickets, T-shirts, or any other team gear such as jackets, racing uniforms, hats or other official team clothing.

**THEREFORE IT BE ENACTED by the Legislative Council of the University of Colorado Student Union that:**

**section 1:** The Spring 2000 UCSU ballot will include the following question:

Purpose: Colorado Crew is a student group that competes in the Mid-West in regattas held throughout year. We race against schools from the Big Twelve and the PAC-10. Crew, a student run and comprised of university students, is governed by a constitution and follows all rules, set forth by UCSU.

Budget: This funding is to be used for transportation, lodging and operating costs of Colorado Crew. This includes bus service, gasoline costs, towing and transportation costs of our boats, hotel and lodging costs, and food while on official team trips. This funding is also to be used for the costs of photocopies, including team handouts used in recruitment, team meetings, public relations packets and other mailings. Included in operating costs are also yearly fees paid to the Boulder Reservoir the Rocky Mountain Rowing Club, USRowing, the Western Intercollegiate Rowing Association, boat storage

costs, gasoline for daily practice. This funding is not to be used to purchase equipment or spare parts.
