A Bill (Special Order)

Bill History

50 LCB #6 directed several changes in the categorization of students for collection of student fees. This bill was never implemented at the Bursar's Office because of the implementation of the PeopleSoft components of the Academic Streamlining Project. Following discussions earlier this year aimed toward an implementation of 50 LCB #6, certain ambiguities were discovered in the wording of the bill that must be corrected before implementation.

Bill Summary

This bill voids 50 LCB #6 and replaces it with a set of guidelines consistent with the original intent of that bill but removing the ambiguity over certain classifications. This bill also directs the Bursar's Office to implement the bill for the 2001-2002 academic year.

THEREFORE, BE IT ENACTED by the Legislative Council of the University of Colorado Student Union, THAT:

a. **SECTION 1:** 50 LCB #6 is declared null and void.

SECTION 2: Beginning with the 2001-2002 academic year, a new schedule of student fee categorization shall be in place with the Bursar's Office.

SECTION 3: The new categorization for student fees shall be as follows:

A. Undergraduate fees:

1. ACCESS (formerly SAVE) students shall have the option to pay full UCSU fees or no UCSU fees.
2. Continuing Education students shall have the option to pay full UCSU fees or no UCSU fees.
3. Undergraduate students enrolled for one class of 5 or fewer credit hours shall be assessed UCSU base fees.
4. Undergraduate students enrolled for more than one class and/or 6 or more credit hours shall be assessed full UCSU fees.

B. Law Students:

Law Students shall be assessed full UCSU fees for all semesters of enrollment in the Law School.

- C. Graduate Fees (applies to graduate students not in the Law School):
1. Graduate students shall be assessed full UCSU fees until completion of 30 credit hours.
 2. For all semesters of enrollment after the completion of 30 credit hours, graduate students shall be assessed UCSU base fees.
- D. All Students:
1. Any student paying UCSU base fees shall have the right to pay the full UCSU fees. Sponsored students shall be responsible for UCSU fees above base fees if they are not assessed full UCSU fees by default.
 2. Any student paying UCSU base fees shall have the right to pay the Wardenburg portion of UCSU fees for the purpose of purchasing health insurance.
 3. Any student paying UCSU base fees shall have the right to purchase student affiliate memberships for the Recreation Center.
 4. Any student who is residing and either employed by the university and/or performing coursework (such as student teaching or full-time field research) outside of five-county RTD district may petition for a waiver of UCSU fees above base fees.

SECTION 4: The Bursar's Office, in conjunction with the UCSU Office, Wardenburg Health Center, Recreation Center and Environmental Center (for RTD bus passes), shall design and implement a student fee collection and waiver process in accordance with these rules.

SECTION 5: This bill takes effect upon passage.
