#### A Bill

#### Bill History

The election code is necessary for guiding the election process and all changes must be made to the code by February 14 in order for them to be effective for the next election.

### Bill Summary

The proposed changes are being made by the election committee in order to facilitate a better election process and to ensure compliance with all applicable university guidelines.

# Therefore, be it enacted that the Legislative Council of the University of Colorado Student Union, that:

**Section 1:** Article I, section 4.11 will be amended to include "A non-exhaustive list of such offenses includes violation of chalking regulations, and removal or destruction of campaign materials of another candidate or referenda group."

**Section 2:** Article I, section 4.22 will be amended so that "Section 4.9" will read "Section 4.10"

**Section 3:** Article V, will have section 1.6 added which will read, "The tabulation process, to be completed by a group consisting of the Election Commissioner, UCSU Information Technology Director, and a member of the election committee will begin on Friday morning. Preliminary results will be made available Friday 10:00am, the week of the election."

**Section 4:** Article VI, section 2.10 will be amended to add "(4) An official email address issued by the University of Colorado" to the list of what must be included on the petition.

**Section 5:** The first sentence of Article V, section 1.3, will be amended to read, "The Mandatory Candidates' Meeting shall be held after 5:00 pm on the Monday evening three weeks before the elections. The Mandatory Referenda Meeting shall be held after 5:00 pm on the Tuesday following the Mandatory Candidates' Meeting." Article 5, Section 1.4 of the Code is changed to read 11:59 Friday. The word "morning" is struck from

Section 3. "Friday" will be replaced by "Saturday" in Section 3. Results will be made available by Saturday at 2:00 am.

**Section 6:** Article VI will have section 6.5 added which will read "There shall be no links to outside web pages from the official UCSU biography page for the candidates and referenda groups. Any outside links or any other changes to web postings appearing after the deadline set by the election commission shall automatically be removed by the election commission."

**Section 7:** Article VI, section 7.4 will be amended so that point 5 will become point 6 and a new point 5 will be added reading "Official University of Colorado e-mail address"

**Section 8:** Article VI, section 13.4 will be amended to read, "Legislative Council will not hear any appeals."

**Section 9:** Article VI, will have section 13.6 added which will read, "The Appellate Court's findings shall be final."

**Section 10:** This bill will take effect upon passage and will apply for the election beginning on April 8, 2002 and all subsequent elections.
