## Committee Appointments Bill

## BILL HISTORY

In previous sessions of the UCSU Legislative Council, the president has exercised the power to appoint committee membership. While this has established a precedent, it continues to be in direct violation of the UCSU governing documents. This bill seeks to rectify the aforementioned discrepancy.

## BILL SUMMARY

In the interests of simplicity and expediency this bill modifies the method of committee appointment, so that such methods are consistent with the current practice of the Legislative Council. The Legislative Council has traditionally used method c) Nominations by the Chair found within Robert's Rules Rules of Order Newly Revised $10^{\text {th }}$ Edition.

THEREFORE BE IT ENACTED by the University of Colorado Student Union Legislative Council, THAT:

Section 1: A new section 4 shall be inserted under Article VI § A of the UCSU Bylaws reading, "The method of Ad Hoc Committee appointment shall be "Nominations by the Chair" as outlined in Robert's Rules of Order Newly Revised $10^{\text {th }}$ Edition most current edition unless otherwise specified by the motion establishing the committee. Membership must be ratified by the Legislative Council."

Section 2: Article VI § B (2a) of the UCSU Bylaws shall henceforth read, "The appointments committee shall consist of five members chosen from the Legislative Council. The method of committee appointment shall be "Nominations by the Chair" as outlined in Robert's Rules of Order Newly Revised $10^{\text {th }}$ Edition most current edition. Membership must be ratified by the Legislative Council."

Section 3: Article VI § B (3a) of the UCSU Bylaws shall henceforth read, "The Rules Committee shall consist of up to ten members chosen from the Legislative Council. The method of committee appointment shall be "Nominations by the Chair" as outlined in Robert's Rules of Order Newly Revised $10^{\text {th }}$ Edition most current edition. Membership must be ratified by the Legislative Council."

Section 4: Article VI § B (4a) of the UCSU Bylaws shall henceforth read, "The Election Committee shall consist of up to ten members chosen from the Legislative Council. The method of committee appointment shall be "Nominations by the Chair" as outlined in Robert's Rules of Order Newly Revised $10^{\text {th }}$ Edition most current edition. Membership must be ratified by the Legislative Council."

Section 5: This bill shall take effect upon passage by the UCSU Legislative Council.
