Whereas, the new logo has been approved by many members of the student body to make sure they support and are respondent to it;

Whereas, the new logo will be used for "swag" purchases and outreach efforts to represent CU Student Government to the students.

THEREFORE, BE IT RESOLVED by the Legislative Council of the University of Colorado Boulder Student Government, in a simple majority THAT:

#### Section 1: Amend Section 3 of 77LCB21

- a. Amend the summary to strikeout "and all" and "but not limited to"
- b. Strikeout "Student Group Funding Board" and replace it with Student Organization Allocations Committee in Section 3.3
- c. Strikeout Section 3.7.a-c.
- d. Strikeout Section 3.8.a-e.
- e. Strikeout Section 3.9.g-h.

#### Section 2: Amend Section 7 of 77LCB21

- a. Strikeout "Student Organizations Finance Office" and replace it with "Center for Student Involvement"
- b. Strikeout "Student Group Funding Board" and replace it with Student Organization Allocations Committee

# Section 3: Add a "Section 8: Implementation of CU Student Government Marketing Logo" to 77LCB21 shown in Appendix B

- a. Section 8 will read:
- 1. Any University of Colorado Student Government promotional materials including but not limited to:
  - a. Apparel / Clothing
  - b. Nametags / Placards
  - c. Pens, Water Bottles, Stickers, etc.
- 2. Any and all University of Colorado Student Government electronic communications including but not limited to:
  - a. Website(s)

- b. Blog(s)
- c. Facebook Page(s)
- d. Email Correspondence Signatures (all staff members from all three (3) branches) for those who have email addresses created solely for CU Student Government use (eg. cusg.president@colorado.edu)
- e. PowerPoint Presentations
- f. Flyers (event or otherwise)
- g. Materials promoting CU Student Government elections by the Election Commission (not to be construed to include materials produced by tickets, candidates, and/or political parties in furtherance of a campaign)


